Protecting Vulnerable Children in a Social Media World



1. Governments in some countries require schools and organizations/institutions working with minors (under 18) to have parental/guardian photo release forms. Our church partners will have release forms signed. Please still ask permission to take photos.
2. Governments require children's homes fostering to blurr/block faces of children on all social media and internet sources or for children in schools/churches who do not have signed release forms. Examples provided in photos above.
3. Names of children, specific locations and personal history associated with those names are NOT permitted on social media. Too much personal information places children at risk for cyber crimes as well as making them vulnerable in their own society. Use initials of the child on social media. "We had a wonderful morning blowing bubbles w/ J." Example of what not to do: Jeremiah lives by himself, struggles to eat. He sleeps on the street near the hospital in Santiago." Gives information that could be used against him both by citizens in his community and by cyber criminals.
4. Do not communicate online with children or minors in the country you visit. We caution all online communication, but interact with adults at your own risk. SCORE cannot be responsible for fraud, deceit or monetary requests. SCORE is happy to facilitate ethical correspondence through the Child Sponsorship Program. Contact SCORE if you would like to inquire about helping a specific child.
5. Remain in public at all times with children. Remember you are a stranger even if they don't treat you like one. Please be aware of appropriate physical interaction.
6. If videos and photos are to be shown in a service at church, please make sure faces and information are not published online. Please follow all of the above guidelines if services are published online.

This policy applies to all countries to avoid confusion. It is based on certain laws & international ethics when working with children.
